Look to your windows for energy savings. Use weather stripping on old windows, and, if you can, add storm windows. In hot climates, add solar film screening to west-facing windows to catch heat. For new units, consider doubleglazed panes; in cold climates, "low-e" coatings on glass can help reduce heat loss.

Upgrade window treatments to keep sun out



If the sun loves to beat on your house all summer, show it who is boss by updating your window treatments.

Do not stop with new drapes or indoor blinds. The sun will fade and ruin them unless you also add sunscreens, especially on the west and south sides of the house. You can mount sunscreens on the inside of the windows under your drapes.

Invest in honeycomb shades with double cells, which are easy to install, reasonably priced, and come in a variety of colors. A tip: Choose a style that allows you to lower the window cover from the top down instead of having to raise it from the bottom up. That way, you will still get a lot of light and have a nice view of the sky without letting direct sunlight into the room or sacrificing your privacy.

Just like a helmet and pads are required on a football field, safety safety measures like using equipment guards, wearing eye and ear protection, and securing items are essential for DIY tasks. Read and

But before you tackle

follow directions on every power tool you use. Wearing eye and ear protection and gloves, as well as tying back loose hair and securing loose clothing, are all important to keeping you safe. If 87900 renting a tool, ask the store for safety tips.

Look up, down, and all around

For outside projects, first check the area where you will be working. Identify potential hazards and take time to avoid or correct any problems. Do not forget to look up for power lines, and avoid using long poles or ladders within 10 ft. of overhead wires.

Will your project involve any digging? Call 811 before you dig even if you think you know where underground lines may be. The 811 service will mark all underground lines in your area for free before you start work.

Avoid the blitz

Water and electricity do not mix, so avoid running cords through wet areas. Inspect cords for fraying or damage before use, and be sure outlets can handle any extra load from power tools. Overloading outlets can lead to more than a shock: Fire hazards may result from demanding too much from an electrical system. Be honest with yourself

If a job seems like it might be too much to handle, leave it to a professional. Take into consideration heavy lifting, expensive tools that will only be used once, and whether you really have the time. That way, you will not be tempted to skip safety measures.
