- **NEW PHONE SYSTEM.** The local phone number at Stigler, 918-967-4614, will no longer be available. Please call **800-328-2368** if you need to contact the Stigler office to report an outage and for customer inquiries or customer service.
- **NEW TOLL-FREE NUMBER FOR PAY-BY-PHONE PAYMENTS ONLY.** The new phone number is **888-678-1937**. The new number will provide additional security for our customers that utilize the pay-by-phone option. **Please note that this phone number can only be used to make payments.** If you need to speak to an operator or if you need to report an outage, please continue to call us toll-free at 800-328-2368 if you live in anywhere in CHEC's service territory, or dial 918-775-2211 if you live in the Sallisaw area.

## Construction Crews Working in Sequoyah County

Cookson Hills Electric Cooperative (CHEC) has contracted with Gordon Construction Company, Inc. of Stigler to complete several projects this summer. The first project was recently completed along Highway 59 south of Sallisaw, upgrading approximately 2 miles of power lines. This will help with voltage support south by Kerr Lake and also provide additional capacity to allow for future growth. Additional poles have been added for reinforcement to improve reliability and continuity of service.

The next couple of projects will occur near the Muldrow substation with anticipated completion of approximately 8 weeks. Gordon Construction will replace and upgrade poles and wire north of Muldrow at Turnham Road, continuing east along Shamblin Road and ending east of Swan Road.

These system improvement projects are costly and time-consuming investments, but are necessary to provide our members with reliable electric service and to meet the growing demands for electricity.

# Area Students Attend Energy Camp At Hinton, Oklahoma

Cookson Hills Electric Cooperative (CHEC) joined Oklahoma Association of Electric Cooperatives and other electric cooperatives from Oklahoma in sponsoring more than 80 students to attend the YouthPower Energy Camp. The camp was held May 28-31 at Canyon Camp near Hinton, Oklahoma. This year's camp was the largest camp since the program began.

YouthPower Energy Camp is a program for eighth grade students. The camp is designed to help students develop leadership skills and learn about the rural electric cooperative industry. While at camp students formed a coke and candy co-op, electing a general manager and a board of trustees, and ran their own cooperative business.

The students attended sessions on energy, electrical safety, and rural electric careers. Campers enjoyed hands-on demonstrations, climbed a utility pole, rode in a bucket truck, and participated in a low element ropes course. Of course there was time for swimming and lots of games.

CHEC sent four students to camp this year. They were: Casey Smith of Porum, son of Timothy and Amy Smith; Shaun Gragg of Sallisaw, son of James and Donna Gragg; Ethan Brooks of Sallisaw, son of Michael and Wendy Brooks; and Alayna Holcomb of Sallisaw, daughter of Dion and Angela Holcomb. ## Right-of-Way Crews Begin Spraying in July

Cookson Hills Electric Cooperative (CHEC) has contracted with Progressive Solutions LLC, to proceed with our annual brush control program on the rights-of-way associated with the cooperative.

Starting in July, Progressive Solutions' crews will be selectively spraying the tall growing brush under the electric lines, using products that will stop the growth of brush and trees in the right-of-way.

The crews will be spraying areas from Webbers Falls west to the McIntosh County line. The will continue south and west to the Pittsburg County line and east along the Latimer County line to Hwy 82, and continue north to I-40. Locations in Sequoyah County and the eastern portion of Haskell County were sprayed in 2012.

Please note that the people spraying on your property are indeed doing work on behalf of CHEC. The contractor crews' vehicles should be identified by a company name or logo on the door of their vehicle.

Progressive Solutions LLC are responsible applicators and the products 145800 they use were selected based on our concerns for your safety and for our environment. Their service is one of the very effective tools that we use to assure reliable electric service.
